

BVRPC Membership Meeting Minutes

August 13, 2018

Meeting called to order at 8:10 p.m. and membership was notified of the meeting being audio recorded.

Pistol & IDPA –

IDPA- Last shoot had 37 shooters and 7 re-shoots. Next shoot is set for September 2nd.

Combat –

Nothing for combat.

Trap –

Shooting regularly. As of now 3rd place in league. Had 3 shooters go to Grand America.

Jr. Rifle –

We had 4 juniors- David Denkovich, Christopher Denkovick, Abby Dawson and Anthony Dawson- at the Rimfire 22 Match at Camp Perry. 2 of them for the first time and 2 returning from last year. There were 377 competitors. This included adults and juniors. 1 of our shooters missed bronze by 4 points and placed 96 out of 214 in the scope division, and 16 out of 50 for juniors.

The McChesney's- Jimmy, Heidi and Julia- went to the Carbine and Grand Matches at Camp Perry. Jimmy scored a 230/300 for the Grand match. Heidi received a Bronze in the Air Rifle Match that they attended while up at Camp Perry for the other matches.
